Noteworthy Cases & Operational Support

• Region 10 – Updates for the Trooper Officer Involved Shooting from January 18th – On April 28th, a citizen in Carroll County, GA, observed a white van on the roadway near their residence. The occupants of the van were distributing flyers related to a "neighbor murdered a peaceful protester." A Massachusetts tag was provided, and check of Flock cameras showed that the van had recently been near the site of the Atlanta Public Safety Training Center, and a picture of the van was also captured by the camera. Upon review, agents recognized the van as one previously seen and photographed at Intrenchment Creek Park approximately a year ago. Three subjects were later arrested by the Bartow County Sheriff's Office for Stalking (Misdemeanor) and Intimidating a Law Enforcement Officer (Felony). The van was impounded and GBI executed a search warrant on the van on May 9th, along with 3 cell phones and a laptop that were seized at the time of the arrests. Evidence seized from the van included numerous documents, 2 cameras, a computer, and a map. Forensic examinations are being done on all of the seized digital devices.

On May 30th, the GBI, along with the Atlanta Police Department, arrested three people on charges stemming from the ongoing investigation of individuals responsible for numerous criminal acts at the future site of the Atlanta Public Safety Training Center and other metro Atlanta locations. Marlon Scott Kautz, age 39, of Atlanta, GA, Savannah D Patterson, age 30, of Savannah, GA, and Adele Maclean, age 42, of Atlanta, GA, were all charged with money laundering and charity fraud. Agents and officers executed a search warrant and found evidence linking the three suspects to the financial crimes. All three charged will be booked into a local jail and will have a bond hearing scheduled soon. This case is being jointly prosecuted by the Georgia Attorney General's Office and the DeKalb County District Attorney's Office.

- CEACC -- Operation Golden Eagle -- As a result of a proactive online undercover investigation coordinated by the Georgia Internet Crimes Against Children (ICAC) Task Force, the Georgia Bureau of Investigation's Child Exploitation and Computer Crimes Unit (CEACC) and the Bartow County Sheriff's Office Special Operations, 12 people were arrested over a three-day period beginning Thursday, May 4, 2023. "Operation Golden Eagle" took several months of planning and involved the collaboration of 12 law enforcement agencies. The arrestees, ranging in age from 24-64, traveled from areas around Bartow County, GA, with the intent to meet a child for sex. Eleven of those arrested believed they were going to a location to meet with a child and engage in prearranged sex acts. One was arrested for possession of child sexual abuse material found during a search warrant execution. GBI digital forensic investigators were on hand at the operation to forensically process 16 electronic devices that were seized as evidence during the operation. The goal of "Operation Golden Eagle" was to identify persons who engage in sexually explicit communication with children on the internet, arrange to engage in a sex act with the child, and then travel to meet the child for the purpose of having sex. Additionally, the operation targeted those that are willing to exploit children by purchasing sex with a minor.
- From January 1 to May 31, 2023, the GBI has investigated a total of 44 Officer Involved Shootings (OIS). OIS number 44 was on May 27, 2023, Region 10 responding to OIS at the request of DeKalb Co PD to investigate an officer involved shooting which occurred after a stand-off with DeKalb Co SWAT. DKPD officers responded to a 911 call about a burglary in progress. Later, responding officers were informed the burglary in progress was

actually a domestic dispute involving a gun. The 911 caller indicated they were communicating by text with one of the residents who had locked himself inside his bedroom. The caller further stated he was told by the resident he could hear his mother's boyfriend yelling at her and believed he was going to shoot her. Once on scene, responding officers were able to get the resident out of the home to safety. DKPD SWAT was called to the scene. As SWAT officers arrived, they were able to get a woman that was in the home to safety. As SWAT officers went into the home, they saw a subject in an upstairs bedroom armed with a handgun. Officers ordered the subject to drop the gun. The subject pointed the gun towards the officers and was shot by one officer. The subject was taken to the hospital where he was pronounced dead.

- Mercer, GBI Medical Examiner's Office (MEO), & Finance have put together final estimates on costs for the GBI/Mercer Forensic Scholar's Program. Mercer has asked if GBI might be able to fund scholarships for the next academic year (FY24) to get the program off the ground this request was taken to Finance.
- MEO received their Match results for two 2024-2025 fellows. Both have expressed interest in staying with GBI after fellowship.
- MEO was approved for a temporary complement increase for Fellowship year 2024-2025 to host a military applicant.
- Division of Forensic Sciences (DOFS) Director Cleveland Miles attended the Forensic Laboratory Needs Technology Working Group held in Durham, NC.
- DOFS completed the ANSI National Accreditation Board (ANAB) Reassessment conforming with 183 of 186 applicable accreditation requirements.

Georgia Crime Information Center

- GBI has been approved to extend the Georgia Applicant Processing Service (GAPS) contract with Fieldprint for one year until 6/30/2024.
- GBI and Fieldprint continue to have weekly project calls to discuss issues GAPS users are experiencing.
- NCJ Help Desk is gathering agencies' information daily and sending spreadsheets for Fieldprint to create and send users their credentials to access the system.

Investigative Division

- Twenty-five Special Agent applicants have accepted conditional offers and have started the final phase of hiring (medical exam, psychological evaluation, drug test, PAT for non-certified applicants) with projected hire date of June 16, 2023.
- Inspector Terry Howard will graduate from the FBI National Academy in Quantico, Virginia, on June 8, 2023.



Investigative Hours Expended - YTD FY2023





CUSTOMER SUPPORT & TRAINING

GEORGIA APPLICANT PROCESSING SERVICE (GAPS) PROJECT

Project Description - The Information Services section of GCIC is seeking to obtain the services of a qualified and experienced vendor to provide an applicant fingerprinting solution that will electronically capture and submit applicant fingerprints to the Automated Fingerprint Identification System (AFIS) and provide Rap Back services. The selected vendor shall also manage receiving fingerprint search results and disseminating results to the requestor.

Monthly Update - GBI User Acceptance Testing (UAT) continued with daily updates to review issues as they occur for resolution. DECAL and DCH also continued to perform UAT. A soft launch is scheduled April 24 through April 28 and this launch will provide helpful insight into system or operational issues prior to Go-Live. The plan transitioning from Thales to Fieldprint has finalized, and notification dates confirmed. All users will receive notice that the switchover will

begin on April 28th. Thales will go down at 11:59PM on April 28th and Fieldprint would start at 12:00 AM April 29th. May 1 is the Go-Live date for FieldPrint to begin as the new Georgia Applicant Processing Service (GAPS) vendor.

GEORGIA LAW ENFORCEMENT MESSAGE SWITCH (GLEMS)

Project Description - The message switch provides a means of communication between federal, state, and local law enforcement agencies throughout the state of Georgia, the United States, and other countries, and to take advantage of new features and advances in technology. GCIC is looking to upgrade or replace this system.

Monthly Update - GCIC continues to evaluate operations and work with Datamaxx on migrating data to the development environment and preparing the production environment for Go-Live.

HUMAN RESOURCE (HR) TIMESHEET PROJECT

Project Description - Enhancement of the application used by non-sworn units of the GBI for tracking time.

Monthly Update - The developer is awaiting feedback from GBI HR for additional updates.

NATIONAL SEX OFFENDER REGISTRY (NSOR) NOTIFICATION PROJECT

Project Description - The NSOR project will provide Georgia Department of Early Care and Learning (DECAL) the ability to receive NSOR responses as a part of the criminal history background check, in compliance with Federal, state, and local laws to make complete/accurate fitness determinations.

Monthly Update - There are no updates this reporting period.

RAP BACK PROJECT

Project Description - The Rap Back (RB) project will provide the ability to receive ongoing status notifications of criminal history activity reported on individuals holding positions of trust. Georgia's Rap Back System will include the retention of applicant fingerprints, the implementation of an FBI Rap Back Subscription on such prints, and the creation of a validation process for authorized entities to manage such subscriptions.

The Georgia Bureau of Investigation (GBI) is requesting proposals for the Georgia Applicant Processing Service (GAPS) with the Federal Rap Back Subscription Service. The objective of this procurement is to obtain the services of a qualified and experienced vendor to provide real-time, end-to-end, on-line submission of fingerprint images and data. GBI is seeking a program designed to ensure high performance combined with high availability and reliability to the GBI Automated Fingerprint Identification System (AFIS).

Monthly Update - GTA staff reviewed the eRFP and provided risk recommendations to include and GBI included the applicable recommendations. GTA will review the eRFP again before releasing it to DOAS for their review.
