Noteworthy Cases & Operational Support

- Region 7 On Wednesday, October 5, 2023, a large number of search and arrest warrants were executed in Richmond County and Columbia County by GBI, Richmond County Sheriff's Office, and FBI Augusta. Twenty-seven gang members affiliated with "Trvppmoneyy", or Trap Money (Bloods), were arrested. The seizures included approximately 248 lbs. of high-grade marijuana, trafficking amounts of cocaine, methamphetamine, and fentanyl, \$148,824.00 of US currency, three vehicles, and 28 guns. The guns were a mixture of handguns, and large caliber rifles.
- Region 5 An unidentified woman from a 1988 cold case has been identified by genealogy technology as Chong Un Kim, of Hinesville, Liberty County, Georgia. Kim was 26 years old when she was found. Chong Un Kim came to the United States from Korea in 1981 and lived in Hinesville, Georgia before her death in 1988.

On February 14, 1988, GBI's Region 5 Office received a request from the Jenkins County Sheriff's Office to assist with a death investigation. The victim, wrapped with plastic and duct tape, was found inside a large, nylon suitcase that had been placed in a dumpster just north of Millen, Georgia in Jenkins County. The victim had been dead for about four to seven days. The cause of death was asphyxiation. Throughout the investigation, fingerprints and dental records from the victim were compared to other missing persons from around the country. A GBI forensic artist created a sketch of what the person may have looked like which was disseminated to the public. The National Missing and Unidentified Persons System (NAMUS) opened a case. The National Center for Missing and Exploited Children (NCMEC) also created and disseminated a computer-generated sketch. As DNA technology advanced over the years, police resubmitted evidence to the GBI Crime Lab for additional testing. Analysts found DNA on the items submitted, but the profiles obtained were not eligible for entry into the CODIS DNA Database.

In 2023, the GBI sent forensic evidence to Othram, Inc., a leader in using Forensic-Grade Genome Sequencing to develop comprehensive genealogical profiles. Based on the DNA, a genealogical search produced investigative leads that led to Kim's identification. The GBI notified Kim's family in October 2023 about the identification. "Project Justice" funded the DNA testing. The GBI is asking anyone who may have known Chong Un Kim, or has any information about this case, to contact the GBI at 912-871-1121. - Office of Special Investigations (OSI) Cold Case Unit (CCU) The Coleman-Baker Act (CBA) request webform has been on the GBI website Home page since June 30, 2023. Nineteen (19) cold cases are being reviewed at this time. Six (6) were requests from designated family members and thirteen (13) were self-initiated.
- From January 1 to October 31, 2023, the GBI has investigated a total of 84 Officer Involved Shootings (OIS). OIS number 84 was on October 25, 2023. GBI's Region 10 was requested by Douglas County Sheriff's Office for an OIS. Douglas County Sheriff's Office received a 911 call about a person shot in Douglasville, GA. The shooter was still at the location. Deputies arrived on scene, and while identifying themselves and giving commands, entered the home. Police found a man, later identified as Walter Jackson Sr, age 66, shot and laying on the kitchen floor. Jackson died on scene. Deputies saw a woman holding a baby, who indicated the shooter, later identified as Jonathan Christian Roman, age 27, of Douglasville, GA, was in another room. Deputies then saw Roman and continued to give commands of "show me your hands." Roman shot a deputy and retreated briefly before emerging and shooting at the deputy again who was on the ground. Deputies returned fire, hitting Roman. Roman was life flighted to

Grady Hospital, where he is being treated and is in stable condition. The deputy was shot multiple times. He was taken to a hospital where he is in stable condition. The GBI will conduct an independent investigation. Once complete, the case file will be given to the Douglas County District Attorney's Office for review.

- GBI's Medical Examiner's Office Director of Medical Operations and Division of Forensic Sciences Assistant Deputy Director presented on Resiliency at the Georgia/Tennessee/North Carolina Joint International Association for Identification (IAI) Forensic Training Conference held in Cherokee, North Carolina on October 3, 2023.
- Multiple members of GBI's Medical Examiner's Office attended the National Association of Medical Examiners (NAME) Conference held in San Jose, California, October 13-17, 2023.

Georgia Crime Information Center

• The Georgia Applicant Print System (GAPS) was assigned to be the pilot system for development of a Business Continuity Plan. A meeting with the vendor is targeted for early 2024.

Investigative Division

• Fourteen Special Agent applicants accepted conditional offers for employment and have been scheduled for the remaining steps of the hiring process.

- After 30 years of service with the GBI, GCIC CJIS Criminal Justice Analyst Rickey Stinchcomb retired on November 1, 2023.
- Region 3 Crime Scene Specialist/Special Agent James Gibson has been selected as a recipient of the 2023 Governor's Public Safety Award to recognize his dedication and selfless work in the Georgia public safety profession. The ceremony will be held at GPSTC on Friday, December 1st at 9:30 am.
- Several members of the GBI Team participated in the 2023 Georgia Pre-K Week held October 2-6, 2023, visiting and reading to preschoolers throughout the state.



Investigative Hours Expended - YTD FY2024





GEORGIA APPLICANT PROCESSING SERVICE (GAPS) PROJECT

Project Description - The Information Services section of GCIC is seeking to obtain the services of a qualified and experienced vendor to provide an applicant fingerprinting solution that will electronically capture and submit applicant fingerprints to the Automated Fingerprint Identification System (AFIS) and provide Rap Back services. The selected vendor shall also handle receiving fingerprint search results and disseminating results to the requestor.

Monthly Update - The GAPS system is operational.

GEORGIA LAW ENFORCEMENT MESSAGE SWITCH (GLEMS)

Project Description - The message switch provides a means of communication between federal, state, and local law enforcement agencies throughout the state of Georgia, the United States, and other countries, and to take advantage of new features and advances in technology. GCIC is looking to upgrade or replace this system.

Monthly Update - GCIC continues to work with Datamaxx and other SOG Stakeholders to test the production connections and prepare for a fourth quarter deployment date.

HUMAN RESOURCE (HR) TIMESHEET PROJECT

Project Description - Enhancement of the application used by non-sworn units of the GBI for tracking time.

Monthly Update - The developer is working to add the signature function into the current Timecard application.

NATIONAL SEX OFFENDER REGISTRY (NSOR) NOTIFICATION PROJECT

Project Description - The NSOR project will provide Georgia Department of Early Care and Learning (DECAL) the ability to receive NSOR responses as a part of the criminal history background check, in compliance with Federal, State, and local laws to make complete/accurate fitness determinations.

Monthly Update - The NSOR project is moving forward, and the MOU and SOW are in review to be finalized. The IT group for DECAL was able to produce a design that maintains security and meets business requirements. DECAL is working on the timing and building of the webservice development environment, and working on providing the WSDL, IP addresses, ports, and server information to GTA.

RAP BACK PROJECT

Project Description - The Rap Back (RB) project will provide the ability to receive ongoing status notifications of criminal history activity reported on individuals holding positions of trust. Georgia's Rap Back System will include the retention of applicant fingerprints, the implementation of an FBI Rap Back Subscription on such prints, and the creation of a validation process for authorized entities to manage such subscriptions. The Georgia Bureau of Investigation (GBI) is requesting proposals for the Georgia Applicant Processing Service (GAPS) with the Federal Rap Back Subscription Service. The objective of this procurement is to obtain the services of a qualified and experienced vendor to provide real-time, end-to-end, on-line submission of fingerprint images and data, designed to ensure high performance combined with high availability and reliability to the GBI Automated Fingerprint Identification System (AFIS).

Monthly Update - The Notice of Intent to Award was added to the DOAS Purchasing website.
