

BLACK MALES NO DNA MATCH POSSIBLE - Descriptions of Remains – Walker County

- #47 30-55 years, 5 ft to 5 ft 2 in, small build
missing all wisdom teeth except right lower
missing left upper second molar and right upper first molar
missing right upper outside front tooth
silver fillings left upper first molar, left lower second molar, & right lower first molar
mild arthritis right knee
stiff neck (2 fused vertebrae in middle)
died May 1998-June 1999
NO DNA MATCH POSSIBLE
- #50 over 55 years, likely elderly, white (possibly black) male
5 ft 7 in to 5 ft 9 in, intermediate build
no upper teeth
healing fracture left fibula (small lower leg bone)
arthritis both knees and both ankles, right shoulder, and spine
stiff neck – severe arthritis lower neck
pair of black shoes
light color socks
four golden rings: 2 with multiple clear stones, 1 with single clear stone, & 1 band
died May 1998-June 1999
does not match any submitted DNA to point of unique identity
UNLIKELY DNA MATCH
- #56A older adult
missing all right lower molars and first right lower premolar, missing all left lower teeth
missing central lower teeth – only right lower eyetooth and first premolar remain
DNA STATUS PENDING
- #61B adult
impacted, unerupted right lower eyetooth
missing right lower second molar and wisdom tooth
missing right lower first premolar
died Nov 1999-Dec 2000
NO DNA MATCH POSSIBLE
- #73 over 50 years, black (could be white) male, 5 ft 8 in to 6 ft, heavy set or muscular
old fracture right ring finger
significant arthritis spine (“stiff back”) with fused vertebra at mid-back
medical feeding tube through stomach wall (PEG tube)
IV tube, probably in arm or chest
airway tube, probably in mouth
autopsied
missing all wisdom teeth
silver filling left upper second molar
plastic fillings on left and right lower second molars
died Jan 1998-Dec 1999
NO DNA MATCH POSSIBLE
- #74 over 45 years, black male, medium build
left hip replacement with significant healed infection

BLACK MALES NO DNA MATCH POSSIBLE - Descriptions of Remains – Walker County

- amputations of both legs below knees
significant arthritis in spine (“stiff back”)
died Jan 1998-Dec 1999
NO DNA MATCH POSSIBLE
- #76 40 to 60 years, black male, 5 ft 3 in to 5 ft 10 in
grey-black short hair, clean-shaven
missing upper and lower back teeth on both sides, left lower wisdom tooth present
silver fillings on left upper and lower premolars and right lower premolar
plastic filling on right upper canine (“eyetooth”)
died Apr 1999-May 2000
NO DNA MATCH POSSIBLE
- #91 over 50 years, male, 5 ft 10 in to 6 ft 4 in, muscular or heavyset/large frame
severe arthritis spine
died Apr 1999-May 2000
does not match submitted DNA to point of unique identity
- #93 adult male, heavy set or muscular
no lower teeth
arthritis spine (“stiff”)
teal colored diaper
hospital sheet and draw sheet
died May 1998-Jun 1999
NO DNA MATCH POSSIBLE
- #97 probably older adult, possibly male, 5 ft 7 in to 5 ft 10 in
probably died in hospital
illegible white ID band
light color socks
spine fused (“stiff” and immobile back)
mild arthritis knees and hips
severe arthritis both shoulders and both elbows
died July 1998-July 2000
NO DNA MATCH POSSIBLE
- #101 elderly adult (possibly black)
right back side skull surgery, weeks to months before death (healing) with wire & screws
(parieto-occipital craniotomy)
four upper vertebra collapsed – had lost significant height (became shorter)
arthritis toe
plastic filling right upper first premolar
died July 1998-July 2000
NO DNA MATCH POSSIBLE
- #118A adult male, 5 ft 9 in to 6 ft 1 in, heavyset or muscular
died Jan-July 2000
NO DNA MATCH POSSIBLE
- #131 over 35years – middle aged to elderly, black male, 5 ft 4 in to 5 ft 8 in, heavyset or muscular

BLACK MALES NO DNA MATCH POSSIBLE - Descriptions of Remains – Walker County

- missing all teeth
possible old fracture left lower leg (fibula)
slight arthritis both elbows and spine
significant arthritis left shoulder – possible old injury
blue and red plaid, long sleeved shirt, XL size, “Saugatuck” brand
blue and white jacket
navy blue windbreaker with “Shakelee Dist.” logo on back
tan brown corduroy jeans, “Rustlers” brand
pair dark, high top lace-up boots, size 10 ½, “Honchos” brand
socks
red elastic suspenders
state of New Mexico homeless card in pocket
died Jan-Apr 1999
NO DNA MATCH POSSIBLE
- #148 over 50 years, male, 5 ft 7 in to 5 ft 11 in, large frame/heavysset or muscular
probably died in hospital or nursing home
possibly golden necklace
hospital gown
possible old fracture right first toe
old fracture of left arm at or near wrist
multiple old rib fractures
multiple compression fractures – lost significant height (“became shorter”)
moderate arthritis both hips
significant spinal arthritis (“stiff” back)
missing *at least* all right lower teeth (may have been missing more)
died Apr 1998-Dec 1999
NO DNA MATCH POSSIBLE
- #155 adult, possible male, 5 ft 6 in to 5 ft 9 in, heavysset/large frame or muscular
green-blue large size sweat pants, “Sturdy Wear” brand
died Apr 1998-Dec 1999
NO DNA MATCH POSSIBLE
- #163 over 55, male, 5 ft 6 in to 6 ft, medium build
missing all upper teeth
missing all left lower molars
missing all right lower molars and right lower first second premolar
silver fillings left lower eyetooth (canine) and both right and left lower outer front teeth
long pants
boxer shorts
black plastic comb
hospital sock
died May 1998-Jun 1999
NO DNA MATCH POSSIBLE
- #340 lower denture plate only held in by right lower back teeth
“partial lower roundhouse bridge #18-32 Supported by blade implant #29-31”
NO DNA MATCH POSSIBLE

BLACK MALES NO DNA MATCH POSSIBLE - Descriptions of Remains – Walker County

#341 upper denture plate held in by both eyeteeth
only upper eyeteeth remain in place
lower denture plate held in place by both lower eyeteeth and both lower first molars
both lower eyeteeth and both lower first molars remain in place
NO DNA MATCH POSSIBLE

#2006 adult, medium build
old fracture, left arm above wrist, healed at angle (possible bend or bony knot)
NO DNA MATCH POSSIBLE
Unknown date of death

#2036 adult, possible female, medium build
missing all lower teeth – possibly tooth extracted within 6 months prior to death
died Jan-July 2000

#2038 adult
missing all three upper molars on both sides
missing right upper second premolar, right outer upper front tooth, and left outer upper front tooth
plastic fillings right upper center front tooth and left upper eyetooth
partial upper denture plate –
right 1st molar, right 2nd premolar, right center front tooth, left outer front tooth, left 1st molar, and 2nd molar
died Jan-July 2000
