## DUTIES AND RESPONSIBILITIES:

Under direct supervision, respond to requests for autopsies from authorized requesters as defined by the Georgia Death Investigation Act. Learn to perform various technical, administrative, and investigative tasks to assist the medical examiners in determining the manner and cause of death by gathering information, examining evidence, and building case files; make and develop x-rays and ensure film is properly filed in the respective case; take forensic photographs at autopsies; eviscerate body cavities, collect specimens for toxicology, and remove organs; properly prepare fluid samples by bottling and affixing appropriate labels; properly return organs to the body cavity after examination and suture incisions; obtain post mortem fingerprints and palm prints at the time of autopsy; and prepare bodies for release. Maintain the cleanliness of the morgue from any biohazard materials and ensure there are sufficient supplies. This is the entry/training level of the Death Investigation Specialist job series. Incumbents at this level may require additional training or experience to gain full proficiency in some or all of the job responsibilities.

## MINIMUM QUALIFICATIONS:

Completion of an Associate degree from an accredited college or university in mortuary science, health science, criminal justice, or a related field

## OR

Two (2) years as a practitioner in a morgue/mortuary, medical, or criminal justice setting or a related field
