Noteworthy Cases & Operational Support Provided

- As announced in a January 11, 2023, multi-agency news conference held at Glynn County Police Department Headquarters in Brunswick, Georgia, David H. Estes, US Attorney for the Southern District of Georgia stated that the indictment in USA v. Alvarez et. al, dubbed Operation Ghost Busted, charged 76 defendants with involvement in a drug trafficking conspiracy that distributed large amounts of methamphetamine, fentanyl, heroin, and alprazolam in the greater Glynn County area.
- CEACC "Operation Happy New Year" scheduled for January 23-26, 2023.
- GISAC worked with GSP on security for the Governor's Inauguration on Thursday, January 12, 2023.
- Region 5 –working with DOC to investigate corruption and contraband at Smith State Prison.
- Region 10 During an operation on Wednesday, January 18, 2023, a Georgia State Patrol (GSP) Trooper was shot in the abdomen by a subject in a tent. Five GSP Troopers returned fire and the subject is deceased. The GSP Trooper has undergone several surgeries with a good prognosis. There was a firearm found near the subject and two shell casings from the weapon found inside the tent near the subject's body. The GBI Crime Lab was able to determine that the bullet removed from the GSP Trooper matched the subject's handgun. Seven subjects were also arrested during the operation and charged with Domestic Terrorism and Criminal Trespass. Six of the seven arrested received bond on Friday, January 20, 2023. The seventh subject did not receive bond due to being arrested on the same property for Criminal Trespass in May 2022, and one of the conditions of his previous bond was to stay away from the property. None of the seven arrested are from the State of Georgia. Additionally, throughout Saturday night (January 21st)/early Sunday morning (January 22nd) 14 people were arrested by Atlanta PD (APD) and DeKalb County PD when they entered the property. All were charged with Criminal Trespass.
- Numerous vigils/protests took place in Atlanta and other cities throughout the country on Friday, January 20, 2023 and Saturday, January 21, 2023 in response to the shooting and against the building of the APD training center. One of the events in Atlanta on Saturday night resulted in several businesses being vandalized and one APD marked patrol vehicle being burned. As a result, six subjects were arrested on numerous charges to include felony charges of Arson 1st Degree and Domestic Terrorism. One of the six subjects arrested is from the State of Georgia.
- From January 1 to January 23, 2023, the GBI has investigated a total of eight Officer Involved Shootings (OIS). OIS number seven was described above and involved GSP Troopers. OIS number eight was on Thursday, January 19, 2023, investigated by Region 10 and requested by Doraville PD. The subject had active felony warrants when he fled from law enforcement. The subject later brandished a machete and was able to get inside a patrol vehicle with access to several additional weapons inside of the patrol vehicle. More than one officer fired at the subject who was transported to the hospital and treated for non-life-threatening injuries. No law enforcement officers sustained injuries during the incident.

Trainings Conducted and Testimony Provided

Legal Division

- Legal is working with DCS to provide gang database training to:
 - DCS statewide gang staff at GPSTC on January 26, 2023
 - Gwinnett County PD
 - Paulding County DA's office
- Ag Labor Trafficking Special Prosecutor gave a joint presentation at the PAC conference with Assistant US Attorney for the Southern District, Greg Gilluly.
- Executive Director John Melvin assisted the Attorney General's Office, Rabun County District Attorney's Office, and Cherokee County District Attorney's Office with RICO indictments and motions.

Division of Forensic Sciences

- Accreditation Council for Graduate Medical Education (ACGME) Fellowship site visit held on January 17, 2023. Two additional fellowship interviews were held. There are six total applicants for 2024-2025. This is the highest number of applicants in years.
- Vanderbilt Medical Student won the College of American Pathologist Advanced Training Grant and chose the GBI ME's Office over all other programs in the country to attend.
- Director Michael Register provided testimony to the Joint House and Senate Appropriations Committee and, the same day, to the House Subcommittee for Public Safety.

Georgia Crime Information Center

- GCIC is working to migrate the Georgia Applicant Print System (GAPS) Thales to Fieldprint.
- Executive Director John Melvin attended the Joint House and Senate Appropriations Committee on the update of SB411 Criminal Data Exchange (CDX) Board addressing concerns of legislatures after the testimony was received.

Investigative Division

- The 2023 Special Agent Applicant Assessments are scheduled for February 4, 2023 at the Georgia Public Safety Training Center. There are approximately 120 applicants expected.
- The 2023 Office Managers In-Service sessions have been scheduled.

Personnel Matters

• Inspector Mitchell Posey is attending the FBI National Academy in Quantico, Virginia, January 7, 2023 through March 16, 2023.

Facilities Update






PLANS AND PROGRAM DEVELOPMENT


CUSTOMER SUPPORT & TRAINING

Project Description - The Customer Support Training group provides training in GCIC programs, GCIC applications, and GCIC/FBI compliance to criminal justice agencies across the State of Georgia. The group extends the option to receive classroom training or training within an e-Learning environment.

Monthly Update - Training Staff handled 798 emails, 33 phone calls, 19 crystal reports and managed LMS user account additions. Multiple webinars and one-on-one trainings are being completed to meet State of Georgia training needs.







GEORGIA APPLICANT PROCESSING SERVICE (GAPS) PROJECT

Project Description - The Information Services section of GCIC is seeking to obtain the services of a qualified and experienced vendor to provide an applicant fingerprinting solution that will electronically capture and submit applicant fingerprints to the Automated Fingerprint Identification System (AFIS). The selected vendor shall also handle receiving fingerprint search results and disseminating results to the requestor.

Monthly Update - The project plan was reviewed and is updated weekly. The draft of the business requirements document continues, and the scheduling site process flow was provided for review. GBI live scan certification and Rap Back testing was unsuccessful. The vendor interface was not ready, and testing is rescheduled for January 2023.

GEORGIA LAW ENFORCEMENT MESSAGE SWITCH (GLEMS)

Project Description - The message switch provides a means of communication between federal, state, and local law enforcement agencies throughout the state of Georgia, the United States, and other countries, and to take advantage of new features and advances in technology. GCIC is looking to upgrade or replace this system.

Monthly Update - Agency testing has been delayed as GBI works with GTA/ATT on potential DNS issues. GTA/ATT is working on the ticket for the Metro header port to allow vendors that come behind Nlets to connect.

HUMAN RESOURCE (HR) TIMESHEET PROJECT

Project Description - Enhancement of the application used by non-sworn units of the GBI for tracking time.

Monthly Update - The developer discovered a few bugs and is currently working on a resolution.

NATIONAL SEX OFFENDER REGISTRY (NSOR) NOTIFICATION PROJECT

Project Description - The NSOR project will provide Georgia Department of Early Care and Learning (DECAL) the ability to receive NSOR responses as a part of the criminal history background check, in compliance with Federal, state, and local laws to make complete/accurate fitness determinations.

Monthly Update - The project team met to discuss the proposed strategy by Equivant. A meeting will be scheduled to include both NEC and Equivant.

RAP BACK PROJECT

Project Description - The Rap Back (RB) project will provide the ability to receive ongoing status notifications of criminal history activity reported on individuals holding positions of trust. Georgia's Rap Back System will include the retention of applicant fingerprints, the implementation of an FBI Rap Back Subscription on such prints, and the creation of a validation process for authorized entities to manage such subscriptions.

Monthly Update - The testing of Rap Back transactions for vendor compliance was unsuccessful. The interface was not ready.

<u>Server Refresh</u>

Project Description - GBI is working in collaboration with GTA with the replacement, installation and configuration of several server hardware replacements and software installs.

Monthly Update - There are no updates this reporting period.
