Noteworthy Cases & Operational Support Provided

- Region 10 – A large scale operation (100+ law enforcement officers) was planned for Wednesday, January 11, 2023, but has been re-scheduled for Wednesday, January 18, 2023, due to availability of resources. Note: The U.S. Dept. of Homeland Security published a bulletin describing the people participating in the operation at the training site and committing criminal acts throughout the U.S. as Domestic Violent Extremists.
- Region 10 – Request received from Clayton County PD on November 21, 2022, to investigate an OIS that resulted in the death of 19-year-old Eric Holmes. A group of approximately 10 people, including Holmes' mother, peacefully protested at GBI HQ on Thursday, January 5, 2023.
- Region 10 – On December 27, 2022, a body was found in East Point that had some consistencies with Jenna VanGelderren who was reported missing in 2017. After comparing Jenna's dental records, the Fulton County ME's Office determined that the body is not that of Jenna.
- CEACC – "Operation Happy New Year" scheduled for January 23-26, 2023.
- GISAC – Working with GSP on security for the Governor's Inauguration scheduled for Thursday, January 12, 2023.
- HEAT – Arrested a subject, along with HSI, at a hotel in DeKalb County in November 2022. The suspect's cell phone was searched and 8 consumers were identified that purchased commercial sex from the case victim. HSI will take the initial Human Trafficking charge on the pimp, while HEAT will take charges on the buyers/consumers after consulting with the AG's Office.
- As of December 31, 2022, a total of 112 OIS investigations were conducted in 2022.

Trainings Conducted & Scheduled

Legal Division

- Legal will provide Case Law Update and 1st Amendment training for the 2023 In-Service on Thursday, January 5, 2023.
- Legal is working with DCS to provide gang database training to:
 - DCS statewide gang staff at GPSTC on January 26, 2023
 - Gwinnett County PD
 - Paulding County DA's office

Division of Forensic Sciences

- DOFS managers Louis Kriel (Latent Prints), Jim Sebestyen (Forensic Biology), Mike McCarriagher (Trace), and Crime Scene Special Agents Jessica Sales and Casey Sohn visited the Stockbridge Police Department Crime Lab to honor a request for a “walk through with our expertise” from Chief Tim Brown.
- Accreditation Council for Graduate Medical Education (ACGME) Fellowship site visit is scheduled for January 17, 2023. Two additional fellowship interviews are scheduled. There are six total applicants for 2024-2025.

Georgia Crime Information Center

- Meetings held with CDX Board to implement SB440 and correct the data issues flowing from the County Clerk's Office.

Investigative Division

- After completing 13 weeks of Basic Agent training, 29 graduates of the 2022 Special Agent School were honored at the Georgia Public Safety Training Center in Forsyth, Georgia, on Thursday, December 22, 2022.
- 2023 Agent In-Service sessions scheduled.

Personnel Matters

- GBI Command Staff received Leadership training on January 10, 2023 from LDR Leadership, LLC.
- Director Michael Register completed the three step leadership series that makes up the FBI-LEEDA Trilogy -- Supervisor Leadership Institute, Command Leadership Institute, and Executive Leadership Institute.
- Executive Director John Melvin completed the FBI-LEEDA Command Leadership Institute and is working towards Trilogy designation.

Facilities Update

- Awaiting final quote for Conyers Security Fencing; current estimate is at \$370,000.
- Georgia State Financing and Investment Commission (GSFIC) is finalizing the HQ ME Addition with Croft and Associates Architects.
- HQ ME Expansion Project Construction Manager interviews are scheduled for January 18, 2023.

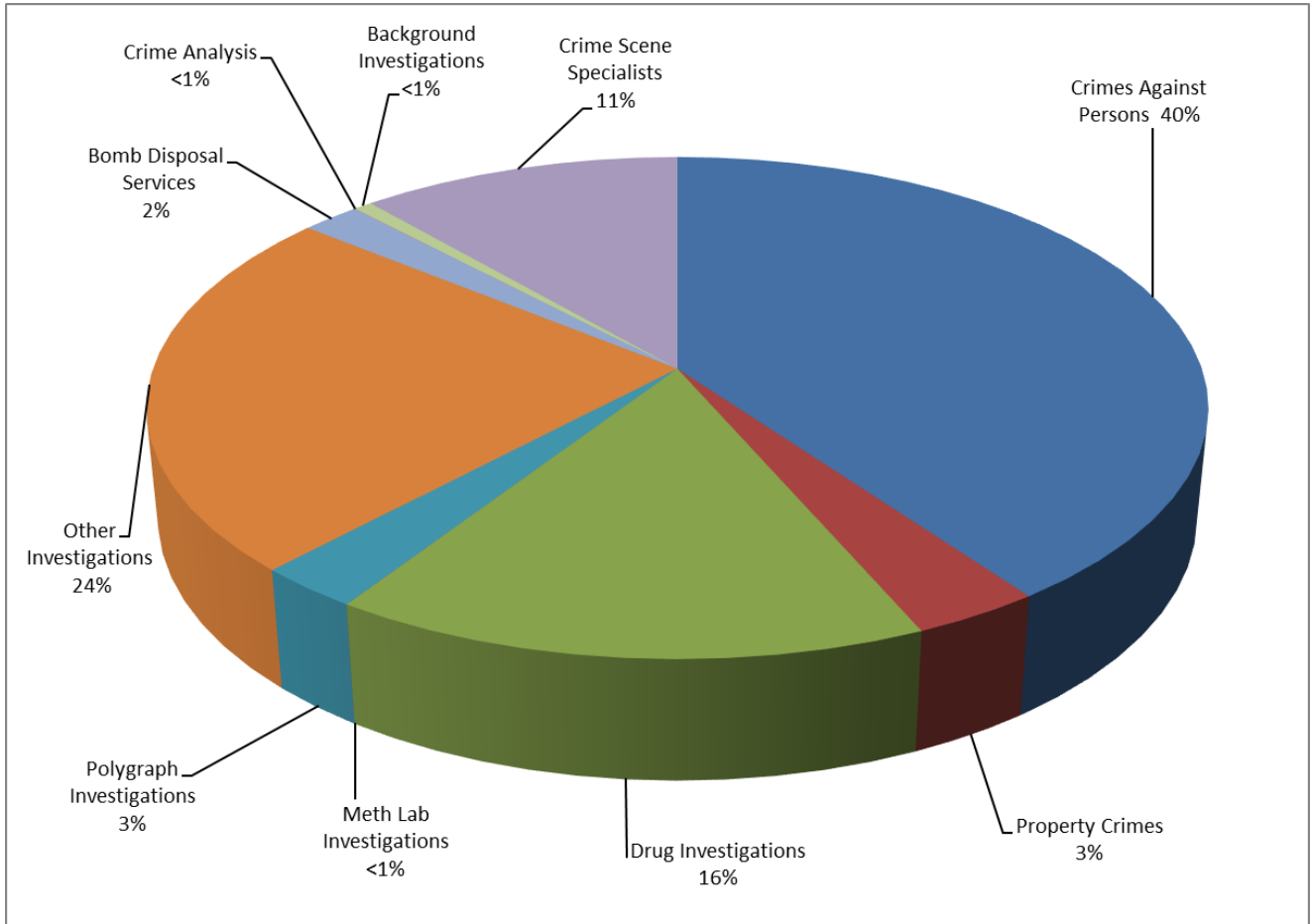

Investigative Hours Expended YTD FY2023



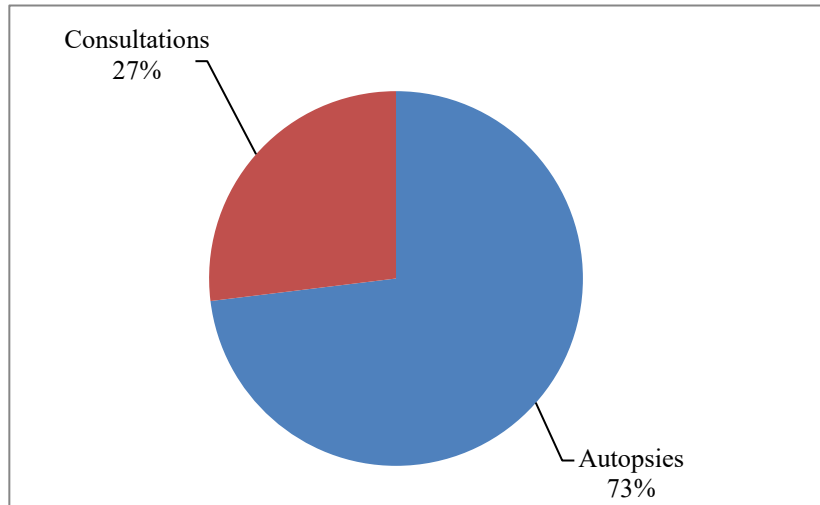

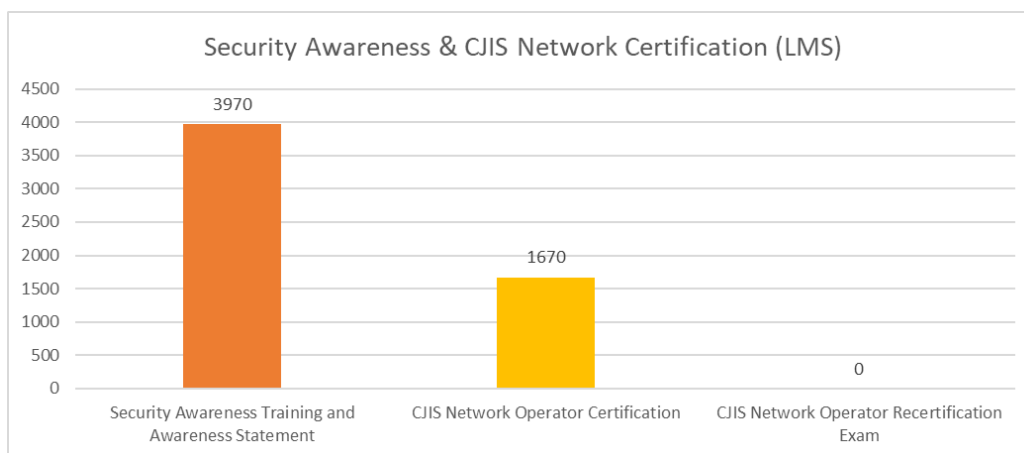
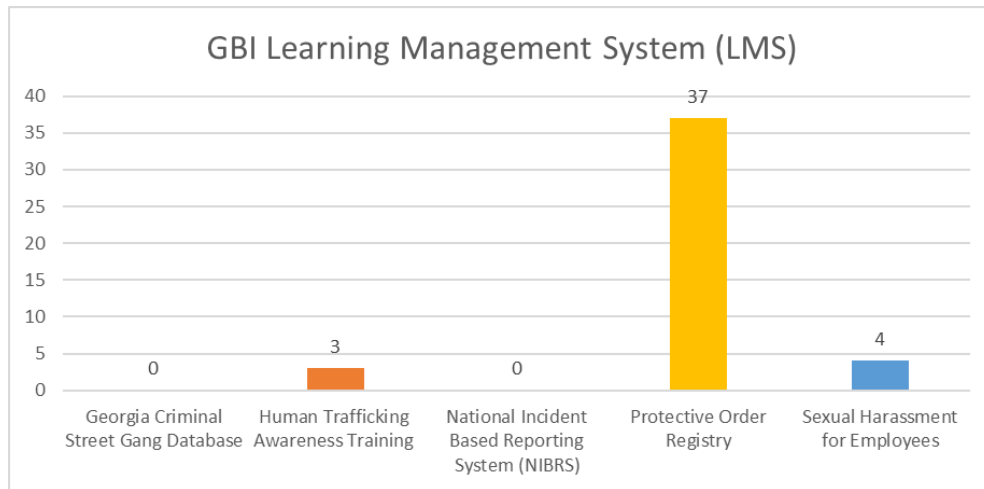
PLANS AND PROGRAM DEVELOPMENT

CUSTOMER SUPPORT & TRAINING

Project Description - The Customer Support Training group provides training in GCIC programs, GCIC applications, and GCIC/FBI compliance to criminal justice agencies across the State of Georgia. The group extends the option to receive classroom training or training within an e-Learning environment.

Monthly Update - The Training Staff handled 995 emails, fifty-two phone calls, 19 crystal reports and managed LMS user account additions. Multiple webinars and one-on-one trainings are being completed to meet State of Georgia training needs.





GEORGIA APPLICANT PROCESSING SERVICE (GAPS) PROJECT

Project Description - The Information Services section of GCIC is seeking to obtain the services of a qualified and experienced vendor to provide an applicant fingerprinting solution that will electronically capture and submit applicant fingerprints to the Automated Fingerprint Identification System (AFIS). The selected vendor shall also handle receiving fingerprint search results and disseminating results to the requestor.

Monthly Update - The project plan was reviewed and is updated weekly. The draft of the business requirement document was delivered to the GCIC team for review and input and the scheduling site process flow was reviewed and updated. Connectivity with GBI is complete.

FieldPrint has an on-going process to increase the fingerprint collection sites in the State of Georgia. The GBI fingerprint kiosk was delivered, and user training is scheduled for next month. GBI live scan certification is scheduled for December.

The GCIC team met with GBI Finance staff to discuss the development process for the Request for Proposal (RFP). Requirements have been developed and are currently under review by GCIC ISO to ensure CJIS Security Policy requirements are met. The proposed date for delivery to DOAS for review and posting is December 2022.

GEORGIA LAW ENFORCEMENT MESSAGE SWITCH (GLEMS)

Project Description - The message switch provides a means of communication between federal, state, and local law enforcement agencies throughout the state of Georgia, the United States, and other countries, and to take advantage of new features and advances in technology. GCIC is looking to upgrade or replace this system.

Monthly Update - Application testing continues. Agency testing has been delayed as GBI works with GTA/ATT on potential DNS issues. A ticket for the Metro header port was completed by GTA/ATT to allow vendors that come behind Nlets to connect. GBI is waiting for the metro vendors to test the application.

HUMAN RESOURCE (HR) TIMESHEET PROJECT

Project Description - Enhancement of the application used by non-sworn units of the GBI for tracking time.

Monthly Update - The developer worked on the signature feature to provide project sponsors with multiple choices. The developer will discuss the best application methods with HR.

NATIONAL SEX OFFENDER REGISTRY (NSOR) NOTIFICATION PROJECT

Project Description - The NSOR project will provide Georgia Department of Early Care and Learning (DECAL) the ability to receive NSOR responses as a part of the criminal history background check, in compliance with Federal, state, and local laws to make complete/accurate fitness determinations.

Monthly Update - The project manager is currently in the process of rescheduling the internal GBI NSOR team meeting to discuss the proposed plan from Equivant.

RAP BACK PROJECT

Project Description - The Rap Back (RB) project will provide the ability to receive ongoing status notifications of criminal history activity reported on individuals holding positions of trust. Georgia's Rap Back System will include the retention of applicant fingerprints, the implementation of an FBI Rap Back Subscription on such prints, and the creation of a validation process for authorized entities to manage such subscriptions.

Monthly Update - The AFIS vendor has provided follow up documentation to GBI IT for review. GBI IT continues to review the proposed network.

SERVER REFRESH

Project Description - GBI is working in collaboration with GTA on the replacement, installation and configuration of several server hardware replacements and software installations.

Monthly Update - There are no updates this reporting period.
