Middle Georgia Gang Task Force (MGGTF) – After a 4-month-long joint drug investigation, the GBI arrested and charged ten (10) people in Milledgeville, GA on a host of drug-related charges. The MGGTF, Georgia State Patrol (GSP), Georgia Department of Community Supervision (DCS), the Georgia Department of Corrections (GDC), the Baldwin County Sheriff's Office, the Wilkinson County Sheriff's Office, and the Milledgeville Police Department worked together in this drug investigation.

On Wednesday, June 12, 2024, GBI MGGTF arrested six (6) people involved in drug trafficking and sales in Milledgeville. These arrests led agents to arrest four (4) additional people on drug and gun charges. While executing these search warrants, agents seized three (3) handguns, three (3) rifles, approximately one (1) pound of suspected marijuana, approximately one (1) ounce of suspected cocaine, one (1) bottle of suspected codeine, and one (1) handgun "switch." GBI MGGTF, GDC, DCS, and GSP conducted this investigation to make an impact on the current drug distribution and gang activity within Central Georgia and to promote a safer place for productive citizens.

 Human Exploitation and Trafficking Unit (HEAT) – On June 20–21, 2024, fourteen (14) people were arrested in Bartow County, GA, in a proactive multi-agency investigative effort targeting sex traffickers and sex buyers in the Northwest Georgia area. The GBI's HEAT Unit, Bartow County Sheriff's Office Special Operations & Criminal Investigation Division, Cartersville Police Department, and Polk County Police Department coordinated the operation.

"Operation Etowah Exploits" involved months of planning and the collaboration of several law enforcement agencies to combat human trafficking. The arrestees, ranging in age from 22 to 59, traveled from areas around Bartow County, GA, with the intent to purchase sex or sell sex. Arrests and charges included: eleven (11) pandering, one (1) pimping, one (1) Violation of the Georgia Controlled Substance Act (VGCSA), one (1) Criminal attempt at child molestation. Police offered resources to nine (9) sex workers. Additional charges and arrests may follow. This investigation is active and ongoing.

The goal of "Operation Etowah Exploits" was to draw in sex buyers for demand reduction and draw in sex workers to offer services. The objective was to identify and arrest pimps and human traffickers through this two-fold approach. The Kennesaw State University Human Trafficking Mobile Medical Unit assisted with the operation as well as the Criminal Justice Coordinating Council (CJCC) by providing resources to the victims.

 Office of Special Investigations (OSI) - Cold Case Unit (CCU) – The Coleman-Baker Act (CBA) request webform has been on the GBI website Home page since June 30, 2023. Thirty-one (31) cold cases are being reviewed at this time. Eleven (11) were requests from designated family members and twenty (20) were GBI initiated. CCU has also opened nine (9) GBI cold case unidentified remains (UID) cases in hopes of identifying the victims with FIGG (Forensic Investigative Genetic Genealogy). • From January 1 to June 30, 2024, the GBI has investigated a total of forty (40) Officer Involved Shootings (OIS).

OIS number forty (40) was on June 30, 2024. GBI's Region 5 – Statesboro Field Office was requested by the Savannah Police Department (PD). Savannah PD Officers attempted to conduct a stop on a vehicle based on information provided by the Chatham County Police Department. The information listed Gregory Eugene Griffin, age 31, as a suspect in a homicide investigation and as driving the vehicle. Griffin attempted to drive away, and there was a short chase. He was traveling in the wrong lane of traffic on E. Victory Drive in Savannah, Chatham County, GA, and hit another vehicle. Griffin got out of his vehicle and began to run. Officers began to chase Griffin, at which time he pulled out a firearm and shot at the officers. Three officers fired their guns and hit Griffin. Officers rendered aid to Griffin, and he was taken to Memorial Health University Medical Center for treatment. No officers were injured in this incident. This investigation is active and ongoing.

The GBI will conduct an independent investigation. Once complete, the case file will be given to the Eastern Judicial Circuit District Attorney's Office for review.




Investigative Cases – YTD FY2024







Medical Examiner data is calculated as >90 days from the date of examination in accordance with National Association of Medical Examiner accreditation standards.


