Noteworthy Cases & Operational Support

• GBI Appalachian Regional Drug Enforcement Office (ARDEO) -- On September 7, 2023, Megan Lowery, age 36, of Morganton, Laura Kilgo, age 55, of Ooltewah, TN, and Amanda Lang, age 41, of Blue Ridge were arrested following an investigation into the selling of pressed fentanyl pills.

Lowery, Kilgo, and Lang were pulled over for a traffic violation on Highway 5 in McCaysville, GA. Police found about 75 suspected fentanyl pills in Lang's possession. Kilgo had about 250 suspected fentanyl pills and suspected methamphetamine. Further investigation revealed that the women had driven to a home in Tennessee to pick up the pills. Tennessee law enforcement authorities later executed a search warrant at the TN home. Police seized over 500 suspected fentanyl pills, money, & two firearms, arresting 10 people on drug related charges.

Lowery was charged with Possession of Drug Related Objects. Kilgo was charged with Trafficking Fentanyl, Possession of Methamphetamine, and Possession of Drug Related Objects. Lang was charged with Trafficking Fentanyl and Possession of Drug Related Objects. All three women were booked into the Fannin County Adult Detention Center.

The Fannin County Sheriff's Office, Gilmer County Sheriff's Office, Dalton Police Department, Cleveland (TN) Police Department, 10th Judicial (TN) Drug Task Force, and GBI's Appalachian Regional Drug Enforcement Office all participated in this investigation.

• Human Exploitation and Trafficking (HEAT) Unit – On Tuesday, September 19, 2023, after a joint investigation involving the Echols County Sheriff's Office and the GBI's HEAT Unit, Genara Juan-Ramos, age 30, of Lake Park, GA, was charged with two counts of 1st degree Cruelty to Children and one count of Human Trafficking.

On February 8, 2023, the Echols County Sheriff's Office requested GBI's HEAT Unit assist with a human trafficking case involving a minor. The investigation revealed that the minor was a victim of human trafficking for labor servitude. The offender was the victim's aunt, Genara Juan-Ramos. After entering the U.S., the minor victim was forced to work in produce fields. Juan-Ramos was also physically abusive to the minor victim. The victim eventually ran away and sought help from law enforcement.

This investigation is another example of interagency collaboration between multiple law enforcement agencies to combat human trafficking.

• Commercial Gambling Unit (CGU) - On Wednesday, September 20, 2023, the GBI's CGU, along with the GBI's Southwestern Regional Drug Enforcement Office, the Tifton Police Department, and the Tift County Sheriff's Office served arrest warrants for six of seven people indicted on multiple gambling related charges. A Tift County Grand Jury returned true bill indictments on Monday, September 11, 2023, for violations of Georgia's gambling laws and related offenses.

Based on the indictments, arrests warrants were secured for the following: Dron Modi, 29, of Tifton; Prajakta Modi, 51, of Tifton; Tarunkumar Modi, 52, of Tifton: Mukeshkumar Patel, 55, of Tifton; Sunny Patel, 22, of Tifton; Jagatpal Singh, 48, of Tifton; and Charles Monroe, Jr., 38, of Tifton. Six are being held at the Tift County Jail. Charles Monroe, Jr. is not in custody, but there is an active warrant for his arrest.

During the course of a lengthy investigation, agents discovered businesses operating Coin Operated Amusement Machines (COAMS) where customers were receiving cash payouts for winning credits. In

Georgia, COAMS must be properly licensed by the Georgia Lottery and credits may only be redeemed for non-cash prizes such as lottery tickets and/or store merchandise.

- Office of Special Investigations (OSI) Cold Case Unit (CCU) The Coleman-Baker Act (CBA) request webform has been on the GBI website Home page since June 30, 2023. Sixteen (16) cold cases are being reviewed at this time. Six (6) were requests from designated family members and ten (10) were self-initiated.
- From January 1 to September 30, 2023, the GBI has investigated a total of 71 Officer Involved Shootings (OIS). OIS number 71 was on September 23, 2023. GBI's Region 2 Field Office was requested by Muscogee County Sheriff's Office to investigate an OIS that occurred in a hotel in Columbus, GA. The subject had multiple warrants out of Lee County, Alabama. As officers approached the hotel room, the subject began firing at the officers, at which time several officers discharged their firearms at the subject. The subject is deceased, no officers were injured.

Trainings and Projects

Legal Division

• During the month of September, four Gang Database Training sessions were held -- Douglas, Georgia on September 7; Appling, Georgia on September 12; Douglasville, Georgia on September 19; and Perry, Georgia on September 27.

Division of Forensic Sciences

- GBI's Crime Lab Director and Human Resources Recruiter attended Emory University's Rollins School of Public Heath Career Day on September 15, 2023, where students were exposed to careers in forensic science at the GBI.
- GBI's Crime Lab Director and Investigative Division Director, along with the Georgia International Law Enforcement Exchange (GILEE) Director, traveled to Amman, Jordan to discuss establishing an exchange program to further training and best practice initiatives.
- Two GBI Medical Examiners attended Emory's Career Day. Multiple students, who previously were not considering forensic pathology, have since contacted our Medical Examiner's Office to set up shadowing experiences.
- Members of GBI Command Staff and Medical Examiner's Office attended the Georgia Coroner's Association Meeting on September 22, 2023.

Georgia Crime Information Center

- The GCIC Staff attended the Sex Offender Registration and Notification Act (SORNA) Conference held September 11 15, 2023, in Arlington, Virginia.
- The Georgia Applicant Processing Service (GAPS) transaction fee increase has been postponed. All agencies impacted were notified.

Investigative Division

- The Child Exploitation and Computer Crimes (CEACC) Unit facilitated an Undercover Chat course the week of August 14, 2023, for 23 Georgia ICAC Task Force affiliates. The CEACC Unit also facilitated an Introduction to ICAC Investigations course the week of September 4, 2023, for 28 Georgia ICAC Task Force affiliates.
- GBI's Leadership Academy, Level 1 Class 1, graduated on August 17, 2023, after completing three training modules over the course of three weeks. The modules are comprised of eight leadership pillars and other pertinent aspects of leadership, such as Teamwork Pillar, Communication Pillar, Media Relations, and Employment Issues. The 25 graduates were a combination of promotable Special Agent 3s and Assistant Special Agents in Charge.
- GBI's Investigative Division personnel facilitated a Resiliency Training course for 18 Crime Lab Managers August 22 24, 2023.
- Twenty-two Special Agent applicants are in the hiring process, polygraphs and backgrounds are ongoing. Command Staff Interviews are scheduled for mid-October.
- Twenty-six new Special Agents started Basic Agent Academy on September 24, 2023.

- On September 18, 2023, Special Agent Rebecca Herold was presented the National Task Force Officer of the Year Award for her work on the FBI Safe Streets Task Force.
- During the 60th International Association of Women Police (IAWP) Annual Training Conference held in September 2023, GBI Inspector Eve Rodgers was presented the 2023 International Association of Women Police Mentoring and Coaching Award.

GEORGIA APPLICANT PROCESSING SERVICE (GAPS) PROJECT

Project Description - The Information Services section of GCIC is seeking to obtain the services of a qualified and experienced vendor to provide an applicant fingerprinting solution that will electronically capture and submit applicant fingerprints to the Automated Fingerprint Identification System (AFIS) and provide Rap Back services. The selected vendor shall also handle receiving fingerprint search results and disseminating results to the requestor.

Monthly Update - Weekly project calls continue between GBI and Fieldprint. Several change order requests are being reviewed and addressed by both entities.

GEORGIA LAW ENFORCEMENT MESSAGE SWITCH (GLEMS)

Project Description - The message switch provides a means of communication between federal, state, and local law enforcement agencies throughout the state of Georgia, the United States, and other countries, and to take advantage of new features and advances in technology. GCIC is looking to upgrade or replace this system.

Monthly Update - GCIC continues to work with Datamaxx and other SOG Stakeholders to test production connections and prepare for a third quarter deployment date.

HUMAN RESOURCE (HR) TIMESHEET PROJECT

Project Description - Enhancement of the application used by non-sworn units of the GBI for tracking time.

Monthly Update - The developer reviewed new policies related to the Timecard Application for possible changes.

NATIONAL SEX OFFENDER REGISTRY (NSOR) NOTIFICATION PROJECT

Project Description - The NSOR project will provide Georgia Department of Early Care and Learning (DECAL) the ability to receive NSOR responses as a part of the criminal history background check, in compliance with Federal, state, and local laws to make complete/accurate fitness determinations.

Monthly Update - The NSOR project is moving forward. The project teams meet to discuss various high and business level aspects of the project, including gathering requirements, connections, and end-to-end information exchange for DECAL to send and receive NSOR Notifications. GBI is in receipt of the vendors change request order and work is being completed to finalize the MOU and SOW.

RAP BACK PROJECT

Project Description - The Rap Back (RB) project will provide the ability to receive ongoing status notifications of criminal history activity reported on individuals holding positions of trust. Georgia's Rap Back System will include the retention of applicant fingerprints, the implementation of an FBI Rap Back Subscription on such prints, and the creation of a validation process for authorized entities to manage such subscriptions. The Georgia Bureau of Investigation (GBI) is requesting proposals for the Georgia Applicant Processing Service (GAPS) with the Federal Rap Back Subscription Service. The objective of this procurement is to obtain the services of a qualified and experienced vendor to provide real-time, end-to-end, on-line submission of fingerprint images and data, designed to ensure high performance combined with high availability and reliability to the GBI Automated Fingerprint Identification System (AFIS).

Monthly Update - Evaluation team members selected a vendor for GAPS. GBI has provided DOAS with an impending contract for review and approval.
