

# **Georgia Authorized Central Storage (ACS) Program Update**

#### Fourth quarter of FY2017 (May 1 to June 30, 2017)


During the fourth quarter, local and state law enforcement agencies used the program to store and dispose of hazardous waste on 7 occasions. These activities resulted in hazardous materials contained within 31 USDOT compliant containers with a total volume of 375 gallons. The total weight of the hazardous waste was 232 pounds.

#### Totals for all four quarters of FY2017:

The ACS program was used to dispose of a total of 1,046 gallons of hazardous waste weighing 683 pounds generated at 93 clandestine methamphetamine lab sites throughout the state.

As stated in previous reports, basic Clandestine Lab Safety (40-hour) training opportunities continue to be a problem for Georgia personnel. The number of seats provided in courses presented at the DEA Academy in Quantico, Virginia are insufficient to keep up with demand. In addition, personnel are no longer allowed to attend the Georgia ACS course prior to completion of the basic lab safety course.

# State of Georgia Methamphetamine







#### PLANS AND PROGRAM DEVELOPMENT

#### AFIS ENHANCEMENTS

**Project Description** - System enhancements for the Automated Fingerprint Identification System (AFIS) which include Accounts Receivable, T-Net fee changes, AFIS -SORT interface, system reports, creation of new IntegraID Document Management folders.

*Monthly Update* - Application development continues for the Sex Offender Registry Tool (SORT) Integra ID Image Archive integration. Testing began on changes for the additional permissions for CCH/Ident and once complete the changes will be ready for production. The tasks outlined for the Document Management additional root folders for Weapons Carry Licenses, Mental Health and IT Security folders will be processed after fiscal year close in July.

#### **APPLICATION DEVELOPMENT – Protective Order Registry**

**Project Description** - In an effort to provide better information sharing, the Georgia Protective Order Registry (POR) is being updated to improve record data quality and expanding database capabilities by replacing the existing application and infrastructure.

*Monthly Update* - The project team completed a deployment plan to transition from the old POR system to the new POR system. The application is scheduled to be deployed during the third quarter of 2017. The IT team is working to demo the new system at the 2017 Symposium.

#### CHILD FATALITY SYSTEM REVIEW PROJECT

**Project Description** - The Child Fatality Review (CFR) unit requested an enhancement to their current process to capture Medical Examiners (ME) data for child related deaths in the State of Georgia and have asked for additional reporting capabilities.

*Monthly Update* - The project was assigned a new project manager and meetings were held to transition the work. Project meetings have resumed.

#### COMPUTERIZED CRIMINAL HISTORY (CCH) ENHANCEMENTS

**Project Description** - The Computerized Criminal History (CCH) system will undergo system enhancements to meet the new State of Georgia legislative changes concerning the First Offender Act (FOA). Additional updates such as system modifications and reports will be implemented for internal users.

*Monthly Update* - The system FOA enhancements were rescheduled to July and consequently affects the schedule of the remaining enhancements by one month. The new project schedule includes testing to begin in mid-August and to be completed at the end of October.

#### CRIMINAL JUSTICE EXCHANGE PROJECT

**Project Description** - The Georgia Bureau of Investigation will programmatically own an initiative of the Governor's Office entitled Criminal Justice Exchange Project (CJEP). CJEP will incorporate the electronic exchanges of information between state and local criminal justice agencies in Georgia. Each exchange automates a manual, paper-based criminal justice business process and will follow a criminal case lifecycle from booking through disposition and

supervision. The goals of the project are to create seamless connections between systems, establish a single, consistent architecture adopted to guide all aspects of program implementation and to establish a governance structure that views criminal justice as a statewide community. The exchanges will involve the coordination of multiple agencies and vendor applications.

*Monthly Update* - The project team reported that the project is behind schedule with completing the business requirements. The business workgroup and the Subject Matter Experts (SMEs) continue to review and provide feedback on the exchange Service Specifications.

#### CUSTOMER RELATIONSHIP MANAGEMENT (CRM) APPLICATION PROJECT


**Project Description -** The CRM Application Project will provide a single source of historical interaction with GCIC external customers. The application will give GCIC end users the ability to search, track and report customer interactions throughout GCIC's business units.


*Monthly Update* - A meeting was held with Microsoft to discuss concerns and issues and a follow-up with the vendor will take place after the project team meets.

#### **CUSTOMER SUPPORT – TRAINING**

**Project Description -** The Customer Support Training group provides training in the area of GCIC programs, GCIC applications, GCIC/FBI compliance and other supported law enforcement training to both criminal and non-criminal justice agencies, municipal, magistrate and probate courts across the State of Georgia. The group extends the option to receive classroom training or training within an e-Learning environment.

*Monthly Update* - The GBI online Learning Management System contains several videos and online classroom training available to agencies and vendors of law enforcement agencies. The trainings completed for the month are included in the charts. The LMS Staff handled 237 phone calls, 1164 emails and managed LMS user account additions and changes.







#### **GCIC TRAINING SYMPOSIUM**

**Project Description** - The GCIC Training Symposium is designed to offer continuing education with the goal of providing vital knowledge regarding GCIC and federal law enforcement programs to both the criminal justice and non-criminal communities.

*Monthly Update* - The project team continues to work on various project tasks in preparation of the 2017 Symposium. The current registration count continues to grow: 328 individuals registered in April; 581 in May and 195 registered in June. Over 1100 people have registered through June.

#### INFORMATION SERVICES CRIMINAL HISTORY APPLICATION REDESIGN PROJECT

**Project Description** - A redesign of the web application used by Information Services staff to log and track activities performed on criminal history information as well as services performed for the public.

*Monthly Update* - The project programmer completed most of the coding on the CCH/AFIS Update log report function. Coding will continue for the minor fixes and is scheduled to be completed by third quarter. UAT will begin after all coding is complete.

#### LAW ENFORCEMENT MESSAGE SWITCH (LEMS)

**Project Description** - The message switch provides a means of communication between federal, state and local law enforcement agencies throughout the state of Georgia, the United States and other countries and in order to take advantage of new features and advances in technology, GCIC is looking to upgrade or replace this system.

*Monthly Update* - The project manager continues to gather requirements to be included in a Request for Proposal (RFP).

#### NATIONAL INCIDENT-BASED REPORTING SYSTEM (NIBRS) PROJECT

**Project Description** - The National Incident Based Reporting System (NIBRS) collects data on each single incident and arrest for each offense coming to the attention of law enforcement for which specific facts about each crime is collected. GBI is in the process of replacing the current UCR summary-based system with an application that will collect incident-based data.

*Monthly Update* - The NIBRS Customization Requirements document created by the vendor is awaiting approval and a signature from GBI. GBI continues with the mapping of state codes to the NIBRS codes, application programming for the Incident data entry page User Interface (UI) customizations, and the Family Violence manual data entry page. Application UAT is scheduled to begin September/October and a project implementation date is set for the end of 2017.

#### SEX OFFENDER REGISTRY TOOL (SORT) ENHANCEMENT PROJECT

<u>**Project Description</u>** - System enhancements for the SORT application. Phase 1 will consist of modifications to the application used by Sheriff's Offices, the public website, NCIC web services and</u>

SORT Reports. Phase 2 will focus on the web service between SORT and AFIS for the upload of SORT documentation.

*Monthly Update* - The project team completed the FBI requirements, updated the bi-monthly Sex Offender Map, and began preparing for Phase 2 implementations.

#### SHAREPOINT CONFIGURATION PROJECT

**Project Description** - The SharePoint tool will be used as an internal web portal for organizing and sharing information as an employee collaborative tool for internal communication. The portal will also include an Intranet application for each of the three GBI divisions that would allow

content management, document repository and information sharing of announcements, news and department information.

*Monthly Update* - The SharePoint Team met with the training unit to discuss training options for the SharePoint project. Training will be conducted in phases and will begin in July. Phase 2 of the project is scheduled to begin in September/October and includes added training for intermediate users. The final phase will include training on best practices and file maintenance (cleaning-up and deletion).

#### WEB SITES REDESIGN PROJECT

**Project Description** - Redesign of the internal and external Georgia Crime Information Center (GCIC) web sites.

*Monthly Update* - The enhancements to the GCIC Extranet content are finalized but have not been presented to the GCIC Command Staff for approval. The changes are scheduled to be demonstrated to the staff in August and implemented into production by September.
