Dear Chiefs and Sheriffs,

The Georgia Bureau of Investigation will begin administering the Clandestine Lab Waste Removal Program, CLWRP, on Wednesday, February 1, 2012.

This program is provided at no additional cost to agencies who want assistance in paying for the removal of waste associated with clandestine methamphetamine labs. The program will only cover costs associated with removing instruments to produce and by-products associated with manufacturing the drug. The program does not cover reimbursements for expenses incurred before February 1, 2012.

Law enforcement agencies wishing to participate in this program may contact the GBI 24 hour Communications Center @ 404-244-2600 or toll free 800-282-8746 when cleanup services are needed.

Any general questions about this program can be directed to the GBI Regional Drug Enforcement Office that covers your county or city. A copy of the RDEO map is attached for your convenience.

Activating CLWRP:

Upon discovering a meth lab, the "on-scene" Investigator, should contact the GBI Communications Center. The Investigator will receive a call back from a GBI coordinator to determine the scope of the incident.

If it is determined that hazardous materials are present and the CLWRP Contractor is dispatched, the GBI Coordinator will need contact information of personnel at the site, as well as the physical location, street address, or latitude/longitude coordinates of the incident.

The GBI Coordinator will then contact the CLWRP Contractor and provide direct contact information of on-scene personnel and physical site location.

Arrival of the CLWRP Contractor:

Upon arrival at the scene, the CLWRP Contractor will provide the "Satisfactory Response for Services, SRFS, Form. Your "on scene" Investigator is responsible for verifying the identity of the contractors who arrive at the site and completing the remainder of that SRFS Form.

Your Investigator will keep the "Agency Copy" of the SRFS Form. Each copy is identified individually at the bottom of each page.

Within 72 hours of the incident the GBI Coordinator will contact your Investigator for follow-up.

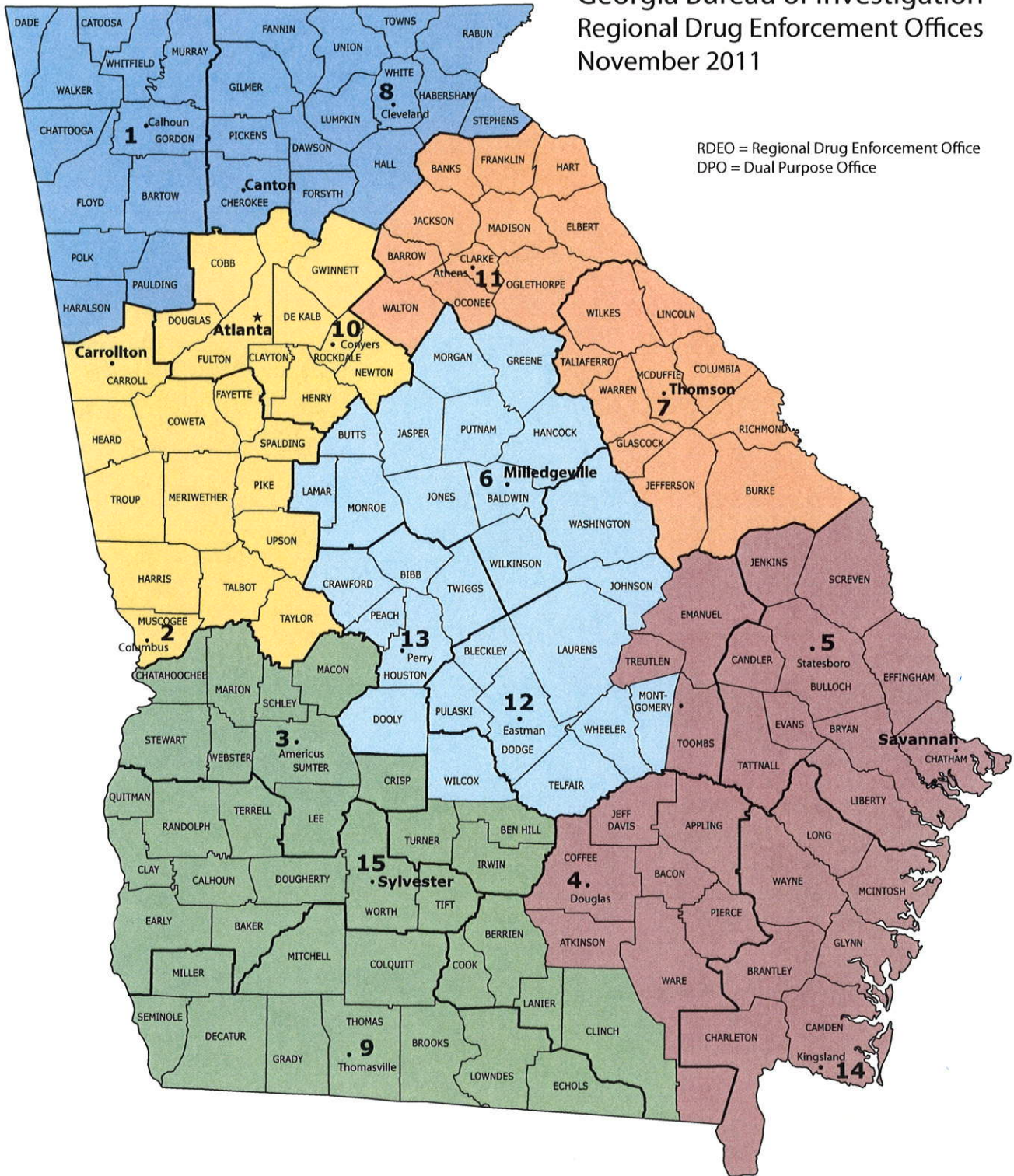
