DUTIES AND RESPONSIBILITIES

The CCH/Identification Services Unit is responsible for all operations and functions associated with the criminal justice use of fingerprints and criminal history record information, such as supporting the Georgia Automated Fingerprint Identification System (AFIS) and the Computerized Criminal History (CCH) database. Duties include providing support to federal, state and local criminal justice agencies and the general public relating to criminal justice information. Unit personnel process fingerprint submissions (arrest and employment/licensing) and final disposition reports. Personnel also update criminal history records to correct inaccurate/incomplete information; inspect criminal history records when someone suspects they have been a victim of criminal identity theft; and, answer phone calls and respond to emails from criminal justice agencies and the general public.

MINIMUM QUALIFICATIONS

High school diploma or GED

PREFERRED QUALIFICATIONS

In addition to the minimum qualifications, preference will be given to applicants that possess one or more of the following:

- One year of customer service experience within a criminal justice environment.
- One year of working knowledge of the criminal history programs and an understanding of criminal history records.
